DIRECTIONS FOR USE

Read entire label prior to use and use product as directed.

1. Shake container before using.
2. Connect garden hose to the nozzle. Make sure dial is in the "off" position.
3. Turn on water at faucet.
4. To spray, point nozzle at treatment areas, turn nozzle to "spray" position. Water will automatically dilute the product.
5. Spray in an even sweeping motion, making sure to thoroughly wet treatment areas.
6. To stop spraying, turn nozzle dial to "off" and turn water off at faucet. Store remaining product in a cool area away from sunlight.
